ISS SUSTAINABILITY SOLUTIONS' NORM-BASED ENGAGEMENT'S APPROACH

ISS Sustainability Solutions' Norm-Based Engagement facilitates engagement with issuers on behalf of participating investors who would like to encourage corporate disclosure of efforts taken to manage or mitigate the environmental and social risks connected to business activities or operations. By engaging collaboratively, participating asset owners and managers can wield more influence than through solo engagements, while saving time and resources.

ENGAGEMENT SCOPE

Through ISS Sustainability Solutions' Norm-Based Engagement, participating investors can focus on companies that are assessed under Norm-Based Research to be involved in alleged or verified severe, systematic, or systemic failures to respect international norms and guidelines on responsible business conduct. The engagements are categorised under the four United Nations Global Compact areas of human rights, labour rights, environment, and anti-corruption. Each engagement is identified by one or several specific topics within these areas, e.g., union rights, workplace discrimination, health and safety, child labour and forced labour within the labour rights norm area. Participating investors have the option to opt in or out of each individual company engagement.

ENGAGEMENT PROCESS

The engagement is preceded by in-depth research and fact-finding dialogues with companies and stakeholders through ISS Sustainability Solutions' Norm-Based Research. Once a company is identified to be involved in a relevant controversy it is considered for Norm-Based Engagement, which is conducted on a rolling quarterly basis. Through these feasibility studies, ISS Sustainability Solutions identifies gaps in company disclosure and assesses whether investor dialogue is an appropriate means to reach the goals set by the participating investors. Influential factors include an estimation of the

company's level of responsibility, steps it has taken to mitigate the possible failure to respect a norm, and the availability of both stakeholder and expert sources to facilitate constructive dialogue.

The engagement dialogue is initiated through letters to companies, sent by ISS Sustainability Solutions on behalf of participating investors. Dialogue may be conducted in writing or through calls and meetings, facilitated by ISS Sustainability Solutions. Some companies require repeated follow-ups to respond. Should the company remain unresponsive, enquiries are escalated to the CEO and the Board. Once efforts have been made to engage both Investor Relations and a company's Executive Management, the feasibility of engagement is re-evaluated.

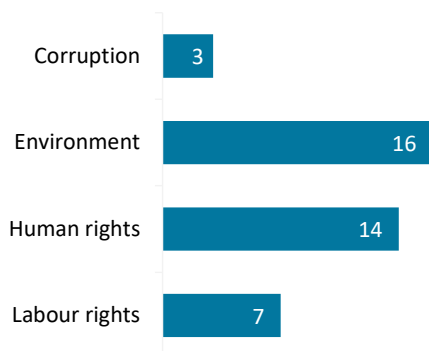
ENGAGEMENT OUTCOMES

At the outset of each engagement, clear and actionable goals are defined within four key categories: disclosure, implementation, remediation and termination. Information provided by the company through the course of the engagement dialogue is assessed against the goals. ISS Sustainability Solutions also assesses the company's quality of participation in the engagement. Where the goals have been fulfilled and the controversy, or the risk thereof, is assessed to be resolved, the engagement is closed. If there is insufficient information to determine whether the goals have been fulfilled, the engagement may be suspended pending developments in the controversy or the disclosure of further information by the company. Alternatively, where there is a poor outlook for the achievement of goals for the engagement, the dialogue may be discontinued.

ENGAGEMENTS INITIATED IN Q4 2025

In Q4 2025, ISS Sustainability Solutions initiated Norm-Based Engagement on behalf of signatory investors with 24 companies, covering 40 individual topics. By 31st December 2025, ISS Sustainability Solutions had received responses from 9 of these companies.

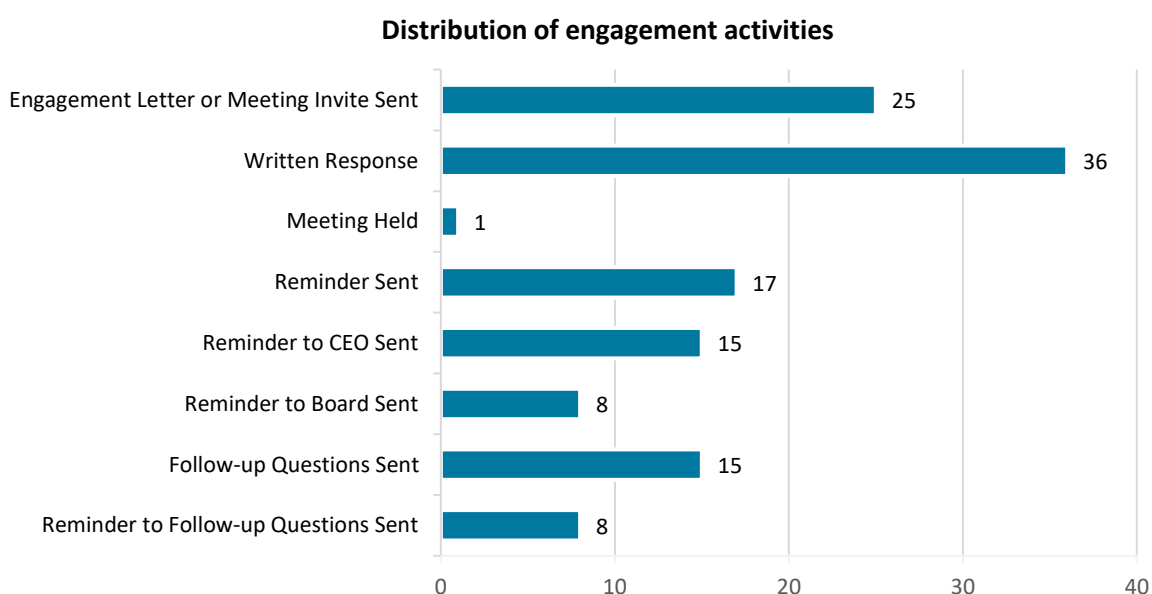

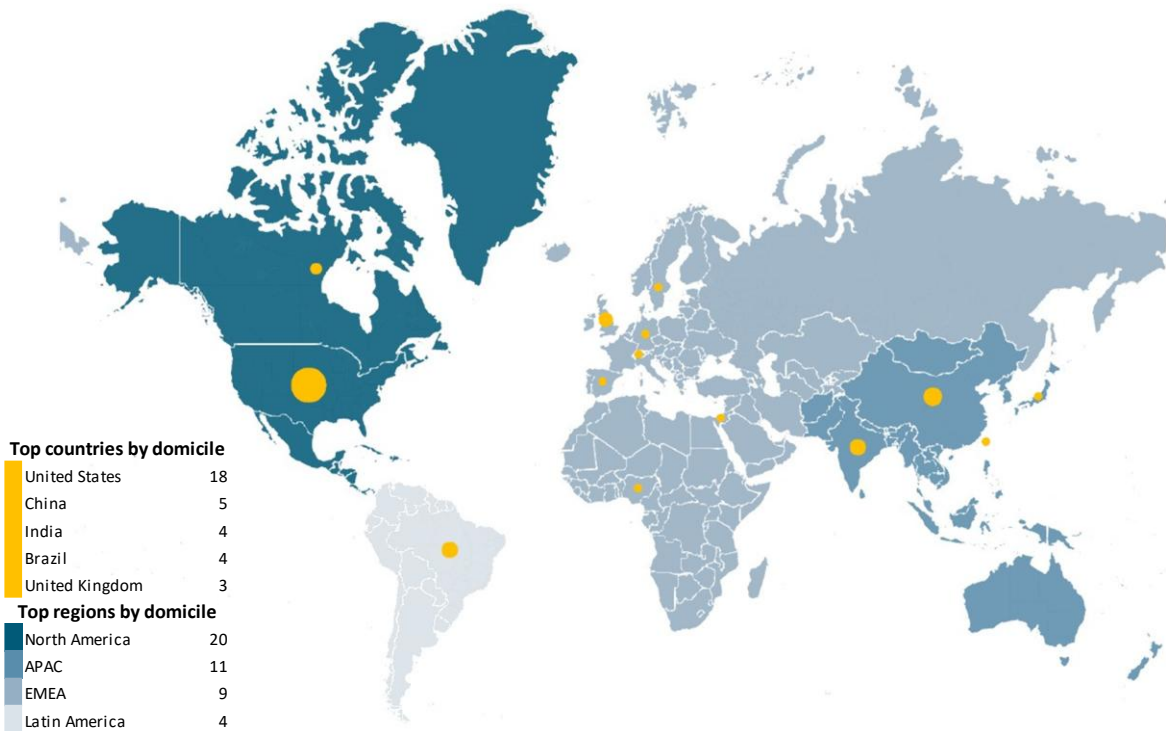
STATISTICS FOR ENGAGEMENT ACTIVITIES IN Q4 2025

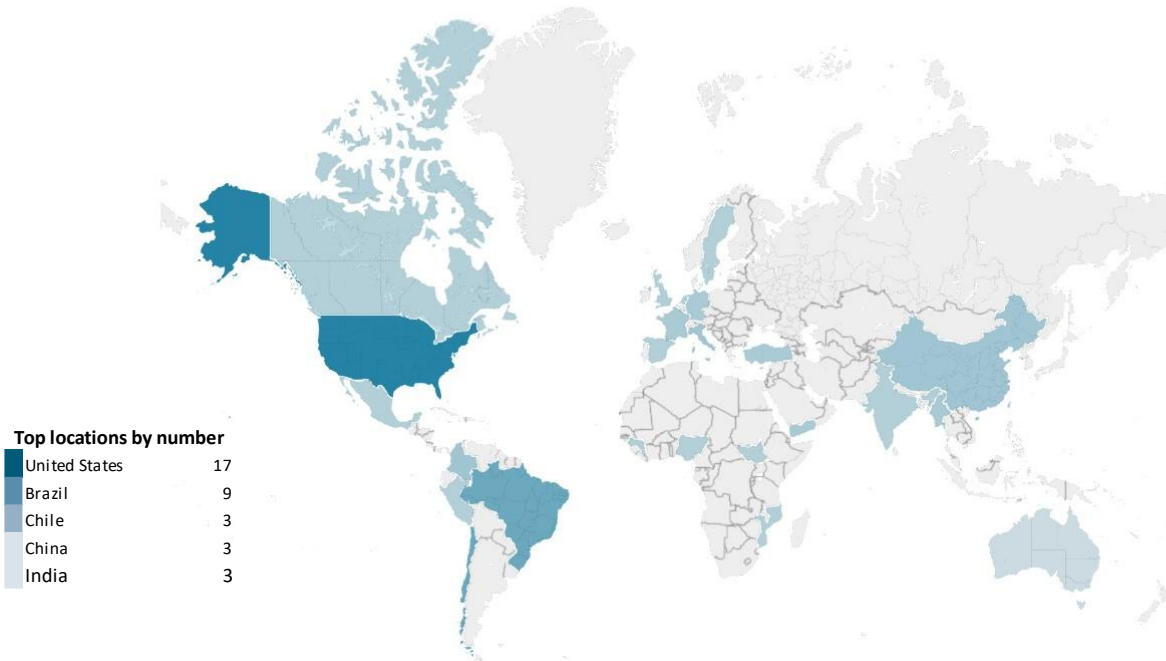
Chart 2. Number and type of engagement activities conducted between 1st October 2025 and 31st December 2025.

The cases below are examples of notable Norm-Based Engagement dialogues carried out on behalf of participating investors in Q4 2025. These activities relate to engagement dialogues that were initiated in Q4 2025 or earlier.

ACTIVITY SUMMARY	<p>Sotera Health Company is a medical specialties company headquartered in the United States (U.S.). In Q3 2025, ISS Sustainability Solutions shared a letter with Sotera Health Company on behalf of participating investors regarding the company's right to health controversy in the U.S.</p>	
	<p>In a written response in December 2025, the company shared that its facilities operate under strict federal, state, and local oversight, with routine inspections and emissions-control systems in place and explained that the Sterigenics business maintains a global Environmental, Health & Safety (EHS) management system supported by internal and external audits.</p>	
	<p>The company further referred to the "Sterigenics EO Facility Enhancements" section of its Corporate Responsibility Report, noting more than 100 million dollars invested in emissions-control technologies designed to reduce EtO emissions below already safe levels and in alignment with updated U.S. Environmental Protection Agency (EPA) requirements. To support its statements, Sotera provided examples of publicly available external assessments, including federally mandated Form R submissions to the EPA detailing EtO use and release, as well as tests, monitoring reports, and engineering studies submitted to relevant permitting authorities.</p>	
	<p>The company also pointed to a range of policies that articulate its commitments to environmental responsibility and community health, including its EHS Policy, Commitment to Environmental Sustainability, Global Code of Conduct, and Human Rights Policy, the latter of which explicitly references respect for the rights of local communities. Overall, the engagement led to the company sharing substantive and verifiable disclosures, reflecting progress in the company's responsiveness to investor concerns.</p>	
	<p>Based on the information Sotera Health Company provided in this engagement dialogue, the company was assessed as having made positive progress on all the engagement goals and as having demonstrated an excellent quality of participation. ISS Sustainability Solutions continues to monitor the efficacy of the company's remediation measures.</p>	

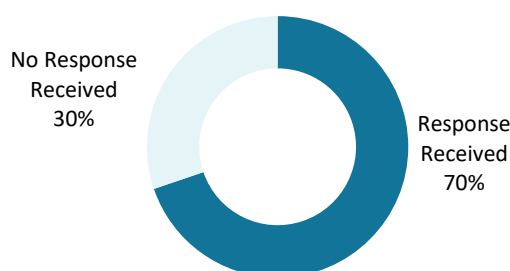

ACTIVITY SUMMARY	<p>Loomis AB is a miscellaneous commercial services company headquartered in Sweden. In Q3 2025, ISS Sustainability Solutions shared a letter with Loomis AB on behalf of participating investors regarding the company’s union rights controversy in Turkey.</p> <p>In a written response in October 2025, the company shared that it recognises the right of all employees to organise, join a trade union of their choice, and engage in collective bargaining in accordance with Turkish law, its Code of Conduct, and CEO instructions, adding that it maintains a neutral stance towards union membership and affirms that employees are free to associate or not associate with any union. Loomis shared that its Turkish subsidiary has multiple channels through which workers can raise concerns related to labour rights, including an integrity line, direct access to Human Resources, engagement surveys, management feedback structures, and a confidential ethics hotline.</p> <p>The company further shared links to its Code of Conduct and Human Rights Policy, which detail its grievance mechanisms. It noted that its CEO instruction on human rights is under development while its Global Rights at Work instruction continues to serve as an internal guiding document. The company explained that it regularly consults with unions, has union representatives on its Board of Directors, and convenes a European Works Council annually to support dialogue between trade unions and management. It further shared that union rights form part of its annual Code of Conduct training for all employees and that a new human rights training programme—developed in collaboration with UNI Global Union and the Swedish Transport Workers Union—is under preparation. The company also confirmed that it is engaged in ongoing discussions with UNI Global Union and that UNI is invited to its annual European Works Council. Overall, the engagement led to the company demonstrating a strengthened level of transparency in response to investor concerns.</p> <p>Based on the information Loomis AB provided in this engagement dialogue, the company was assessed as having made positive progress on all the engagement goals and as having demonstrated an excellent quality of participation. ISS Sustainability Solutions continues to monitor the efficacy of the company’s remediation measures.</p>

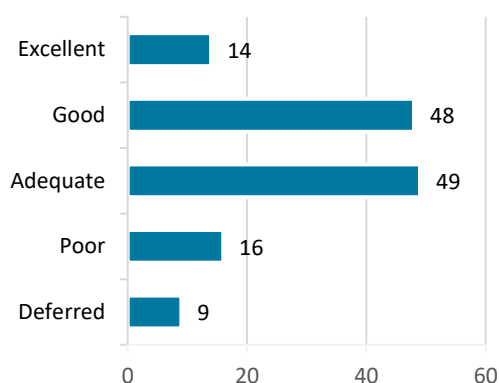

This also applies if the company only shared a link to a relevant report. **Deferred:** The company has replied, acknowledging the enquiry, but has requested more time to respond, transferred the responsibility to another function in the company, and/or agreed to schedule a meeting in which it will provide more information. **None:** The company has not replied.
